# General Terms and Conditions Stefan Seitz, Music Teacher Giessen

### 1. general

These General Terms and Conditions, hereinafter referred to as GTC, apply to the contractual contractual relationship between the music teacher Stefan Seitz, Zur Aue 31, 35415 Pohlheim, hereinafter referred to as the teacher, and the participant or his/her legal representative, hereinafter referred to as the legal representative, hereinafter referred to as the student.

#### 2. Lessons offered

- 2.1. The lessons offered are divided into regular lessons and course packages.

  The regular lessons include the continuous offer in the subjects piano, keyboard, singing as well as a combination of these and individually agreed teaching content from the areas of music theory, music theory, ear training, rhythm and various music software (Finale Notendruck, Cubase) in units of 30, 45 and 60 minutes per week, as well as in course packages of 4-10 units of of 45 minutes each and take place outside the Hessian school vacations and public holidays.
- 2.2. Following a free trial lesson, the student will discuss the individual form of tuition with the teacher. free trial lesson.

## 3. lesson fee

- 3.1. The fee for regular lessons is an annual fee for an average of 38 appointments, which is divided into 12 monthly installments. Deviations may occur depending on the day of the lesson and the location of public holidays. No further fees are due over and above the monthly further fees are due.
- 3.2. The tuition fee for regular lessons shall be paid in accordance with the price list valid at: Stefan Seitz, Sparkasse Gießen, IBAN: DE28 5135 0025 0205 0965 22, Reason for payment: Music lessons due. Alternatively SEPA direct debit procedure possible
- 3.3 If you join up to 4 weeks before the start of school vacations, the lesson relationship (regular monthly amount) will only begin after the vacations, taking into account the lessons received beforehand.
- 3.4. The tuition fees for course packages are due by bank transfer after receipt of an invoice before the startof the first unit.

### 4. provision of lessons

- 4.1. In the case of regular lessons, these usually take place once a week on a fixed date, in the case of course packages on dates to be agreed individually with the teacher.
  Regular lessons are only possible with a minimum contract period of 3 months, alternatively it is possible to book a course package of 5/10 lessons.
- 4.1.1 **Biweekly lessons** must be subordinate to **weekly lessons when making appointments**. In the event that a fortnightly lesson (other week) is canceled/terminated, this date will be merged with another fortnightly lesson.fortnightly student. This **can** also **mean** that you have lessons at a **different time/day.lessons** at a **different time/day**.
- 4.2. Lessons missed for which the teacher is responsible will be made up or reimbursed retroactively to the student's account in the following month. The teacher must offer a maximum of two alternative dates.
- 4.2.1 If lessons are canceled due to teacher illness, there is no obligation to make up lessons once a year
- 4.3. The teacher is not obliged to make up for lessons canceled or missed by the student. Non-attendance does not release the student from the obligation to pay.
- 4.4. **Course package**: If the lesson is canceled due to the student's absence, the lesson is deemed to have been held if it was canceled by the student within 24 hours before the actual date.

### 5. teaching year and vacation regulations

- 5.1. There are no lessons on public holidays and during school vacations in the state of Hesse.
- 5.2. Lessons take place on so-called floating vacations.

## 6. Duration of contract and termination of lessons

6.1. Termination of regular lessons is possible after a minimum contract period of 3 months with a notice period of one full month of lessons to the end of each calendar month (e.g. termination by 30.06. -> end of contract 31.07).

# 7. severability clause

Should individual provisions of the contract be invalid or unenforceable, the remaining content of the contract shall remain unaffected.
